Tatkal Podi for Connecting Land Between Sector 1 and Sector 2

The farmer whose land connects Sector 1 and Sector 2 has applied for Tatkal Podi. The Society has given its consent to proceed with the Tatkal Podi process. This is expected to facilitate the required land-related formalities and help in processing the Sector 2 approval at the earliest possible time.

Meeting with Hoskote MLA

Another important development during the month was the meeting held by the Board with the *Hon'ble Hoskote MLA, Sri Sharath Bachegowda.*

During the meeting, the Board provided detailed information regarding the Third Phase Layout and apprised the Hon'ble MLA about the various hurdles and challenges being faced by the Society in taking the project forward.
